- iii) Kudos excellent start up for all of the staff.
- iv) Budget
 - (1) Lots of things in the media that are frustrating. Misinformation that has been said about school boards and spending. School board budgets are highly restricted and monitored. Reports come quarterly by the finance department. These are available to the public and parents.
 - (2) Operating Budget \$213M. \$211M comes from revenue streams. \$2M to balance which will leave a deficit. Talk to your MLAs regarding the funding in the schools
 - (3) Surplus of \$7.2M, \$5M under the limit that the government provides. Limit is \$12.8M. Surplus is important where you have a little "pocket money" in case



- you need to replace items. IE chiller in Salisbury \$1.2M for that replacement.
- (4) Summer projects 327 planned and undertaken. 6 were Capital. One that was undertaken here an accessible washroom that is being built on this side of the school. Lots of painting.
- (5) Superintendent evals that happened at the end of May
- (6) EIPS 4 year education plan we are in the 4th year. Goals are built around the 4 year plan. Plans remain the same. Election coming up and the new board will develop a new 4 year plan. Will be developed by the survey data that is looked at by the board along with the needs of the division.
